Delete radar Bn, Racon(M), at Capo Peloro Lt in 38°16'·10N 15°39'·00E. AIS remains unchanged. (ILNW 652/19)

4 **Mortelle, Sicilia (Plan D)**

Move Lt 2FI(2)Y.4s2M from 38°16'·34N 15°36'·87E to 38°16'·38N 15°36'·70E (ILNW 491/21)

5 **Giardini Naxos E**

Insert obstn symbol and assoc lgd *Obstn* in 37°50'·40N 15°17'·30E (ILNW 561/21)

6 **Stromboli**

Insert limit of restricted area, entry prohibited, joining:

38°47'·70N 15°11'·43E (coast)

38°49'·18N 15°09'·46E

38°50'·14N 15°11'·21E

38°48'·61N 15°12'·79E (coast) (ILNW 216/23)

7 **Sicilia, C d'Orlando SW**

Insert Y pillar ODAS Lt buoy FI(5)Y.20s with x topmark in 38°06'·1N 14°32'·6E (ILNW 299/24)

8 **Stretto di Messina (Plan D)**

Insert Y Lt superbuoy with x topmark ODAS FI(5)Y.20s in:

38°14'·68N 15°36'·08E

38°11'·54N 15°34'·80E (ILNW 350/24)
