Move R can Lt buoy **20A** FI.R.4s from 53°43'·30N 0°19'·33W to 53°43'·18N 0°19'·49W (ILNW 27/23)

11 Hornsea Project Two Wind Farm

Work on the Hornsea Project Two Wind Farm is complete. Delete lgd *under const'n (buoyed)* centred on 53°53'·32N 1°33'·04E. Amend assoc magenta restricted area linework to black packed line. The limits of the wind farm are marked by lit turbines (ILNW 63/23)

Delete Y special pillar Lt buoy Fl.Y.5s in 54°00'·45N 0°11'·75W (ILNW 295/23)

15 Skegness E

Delete BYB E cardinal pillar Lt buoy **Lincs WFE** Q(3)10s in 53°07'·61N 0°31'·06E (ILNW 28/24)
